



## **4 KING'S BENCH WALK DIVERSITY DATA 2022**

### **1. Introduction**

The Bar Standards Board Code of Conduct states that a summary of the Diversity Data submitted by the Members of the Workforce be published on chambers' website by 31 December 2012 and thereafter every three years. The report for our 2022 data, in accordance with these rules, can be found below. The collection of data and its publication was delayed due to the Covid-19 pandemic.

The information set out below is an anonymised summary of diversity data collected in a survey of current members of chambers (including pupils and QCs) in January 2022. The data was collected pursuant to the BSB Diversity Data collection rules.

Of a total 54 members of chambers, 37 responses to the survey were received equating to a 69% response rate.

The results are based on responses received from those who participated; therefore the results may not reflect chambers in its entirety.



## 2. Explanatory note

In accordance with government guidance on the approach to be taken by public bodies in publishing their diversity data, information is not being published where those in a particular group are fewer than 10 as this would risk their identification. To this end:

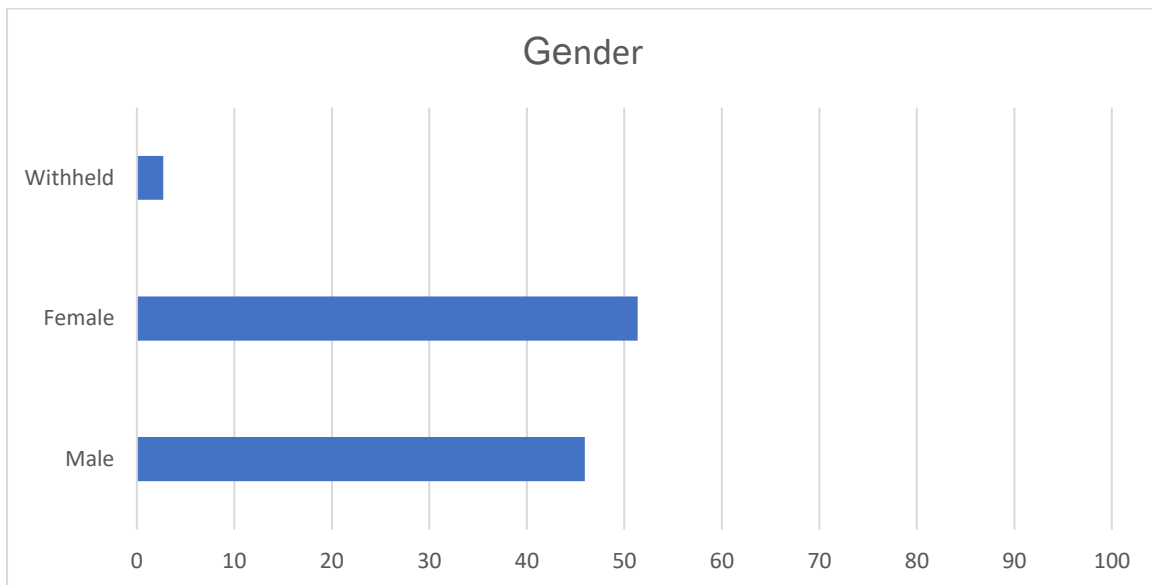
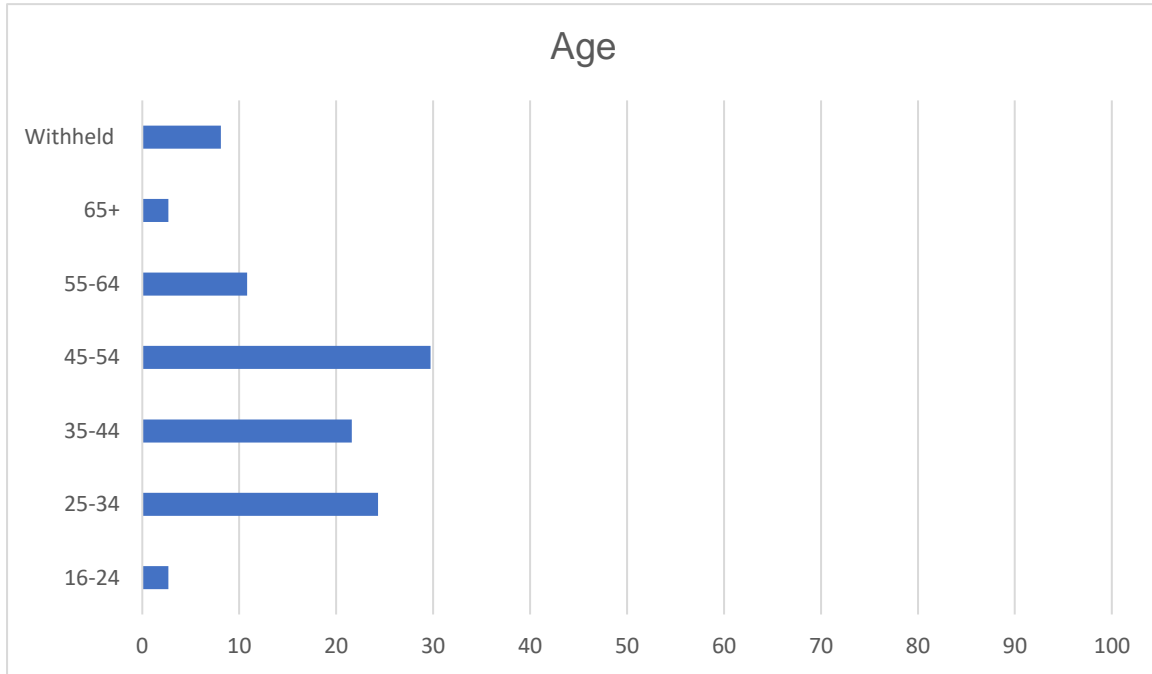
- i. Categories are grouped together where appropriate;
- ii. No data has been published in respect of clerking/administrative staff as there are fewer than 10 individuals in that category;
- iii. The information below is in respect of all barristers (including QCs) rather than broken down by seniority.

Within the charts below:

- i. All figures are percentages of the total number of responses received;
- ii. The term "Withheld" is used to denote members who have answered "prefer not to say";
- iii. The term "Missing" is used to denote members who have left an answer to a particular question blank;

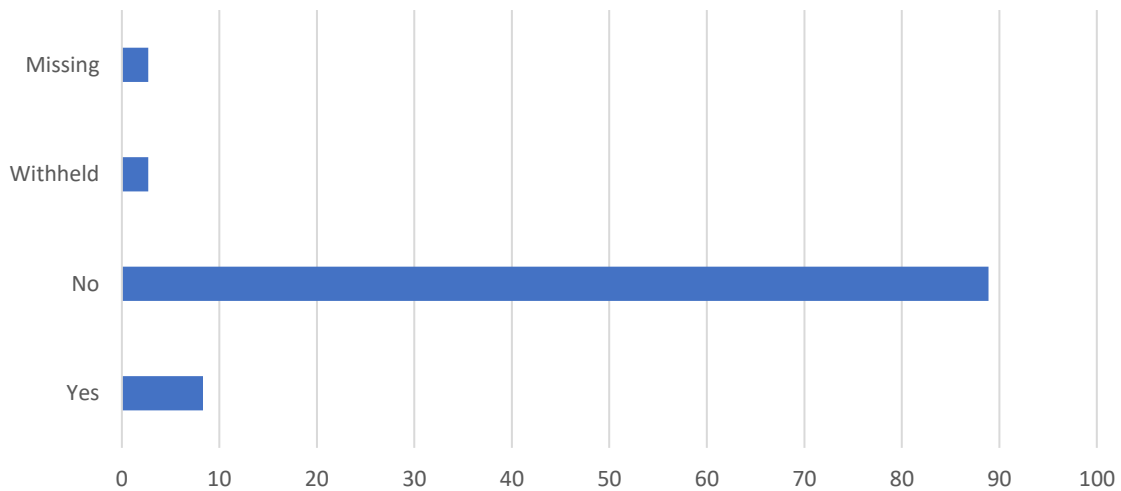

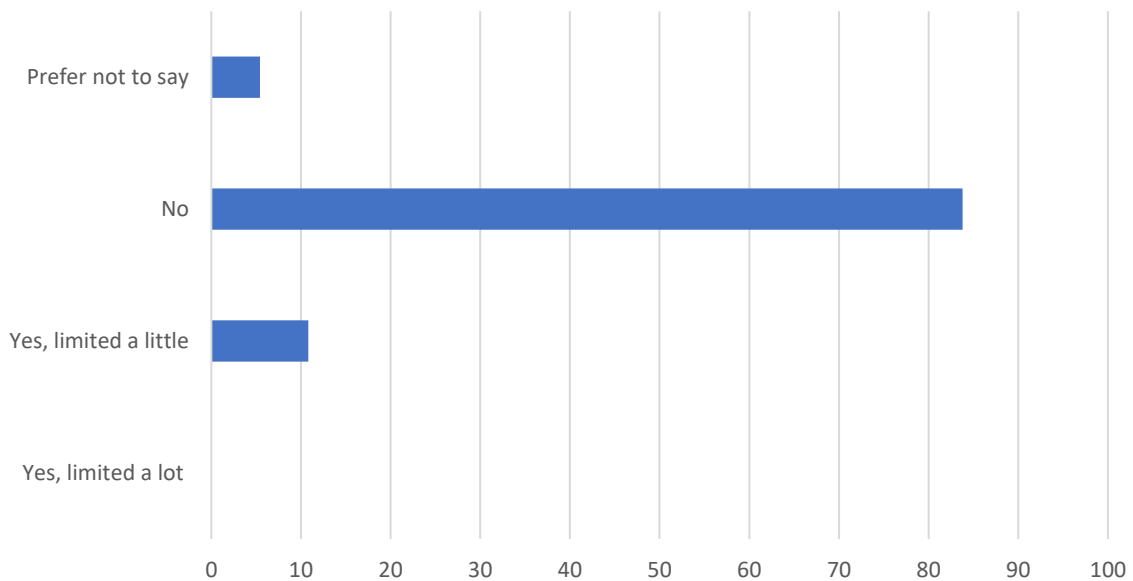
## Disability 1

Day-to-day activities limited because of a health problem or disability which has lasted, or is expected to last, at least 12 months

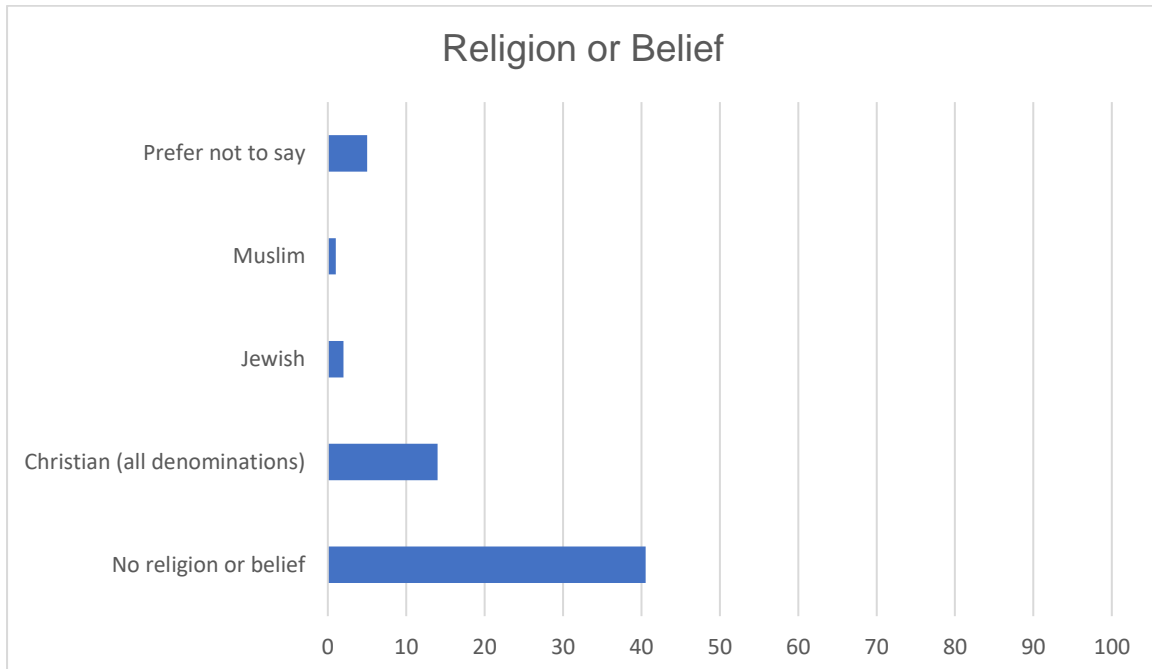
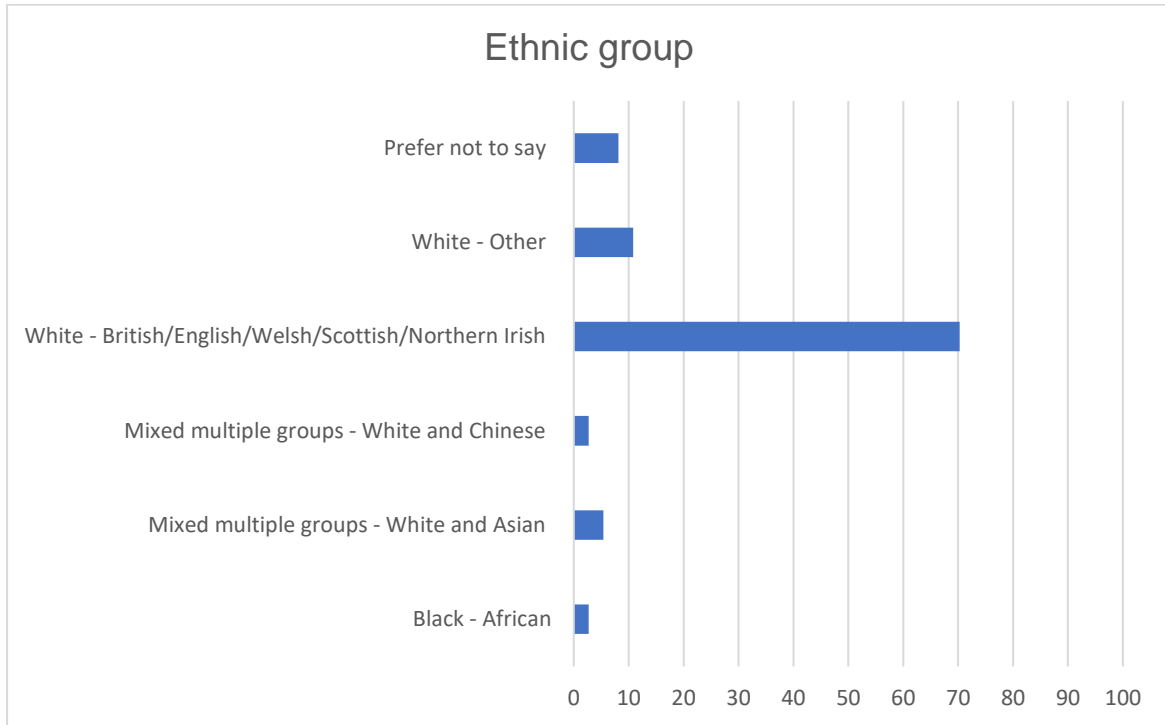
